## **Introduction**

1. The policy outlines the procedure for vaping in schools and academies.
2. VTC School remains a vocational centre where vehicle fumes can be released and there may be other flammable liquids/materials. It is therefore a health and safety matter that vaping and smoking is not permitted.

## **Scope**

### **Who is included in these arrangements?**

3. This policy applies to all employees and learners of VTC Independent School
4. The policy also applies to volunteers, parents, guardians, members of the public and visitors to VTC Independent school.
5. Agency staff and contractors should be made aware of the policy and abide by the vaping arrangements.

### **When does it not apply?**

6. The vaping policy is separate from the school policy on smoking.

### **Vaping on and around the school site**

7. Vaping is not permitted:
  - in any part of the school

- in school grounds
- in school vehicles
- whilst on school or residential trips
- Learners bringing vapes to school **MUST** hand them in to reception on arrival and cannot be collected until after school.
- It remains the learner's responsibility to hand in their vape at reception when entering the school's premises.
- Any learner found vaping within the school or within school hours will be subject to remedial action that can include immediate permanent exclusion.

### **Areas for vaping**

8. As vaping and the use of e-cigarettes is recognised as a method to stop smoking it is at the headteacher's/principal's discretion to allocate an area for vaping.
9. Any designated area for vaping must be away from the view of the learners and members of the public and away from school entrances and windows.
10. Vaping must not take place during paid work time.
11. If staff leave the school / academy site to vape this is only permitted after learners have left the school.
12. Vaping must not take place in a location that will cause reputational damage to the school.

### **School vehicles**

13. All school vehicles are smoke and vape-free. Vehicles will NOT display appropriate signs as all staff are expected to be cognizant of this policy and abide by it.

### **Privately owned vehicles**

14. Any member of staff who uses their own private vehicle for school purposes and transports learners or colleagues must refrain from vaping whilst on duty.
